

1. INTRODUCTION

High Speed Diesel (HSD) is a critical fuel for industries such as logistics, mining, infrastructure, and transportation, Government Road Projects, Readymix Plant, School & College Campus, Spinning Mill Unit, Traditionally, fueling is done via retail outlets or manual barrel transfers, which can lead to inefficiencies, untraceable usage, and loss due to spillage. To address these challenges, we propose the establishment of HSD Consumer Stations that comply with Rule 144 of the Petroleum Rules, 2002, equipped with fuel management systems to ensure accountability and efficiency.

2. EXISTING FUEL STORAGE & USAGE METHODS

Many businesses rely on:

- Fueling at retail outlets, or
- Using barrels to transfer diesel to equipment.

Problems with current methods:

- Spillage and fuel loss
- Manual entry errors
- Lack of real-time monitoring
- Operational delays due to travel for refueling

3. PROPOSED METHOD – CONSUMER STATION

Solution: A legally compliant HSD Consumer Station with underground (UG) storage tanks and dispensers on the premises of the fuel consumer.

Key Features:

- Storage: 12 KL to 90 KL UG tanks
- Tank Type: MS fabricated horizontal cylindrical tanks
- Construction: Earth pit, brick wall, or RCC wall
- Equipment: Air vent, suction pipe, unloading line, dispenser

4. STORAGE TANK SELECTION

We recommend a 30KL storage tank, sufficient for:

- Daily consumption of ~8KL
- Accommodating supply tankers of 12KL, 20KL, or 24KL



5. CONSUMER STATION AREA & REGULATIONS

- **Required area:** 20m x 20m
- **Compliance:** Rule 144 of Petroleum Rules, 2002 & Local Authority Rules

6. FUEL SUPPLY & PRICING

Pricing:

- Revised every 15 days
